Dear Ms. Dinc,

We represent Umut Ozkirimli, professor at Lund University, Sweden. It has come to our attention that certain defamatory statements have been made against our client in what appears to be a deliberate attempt to point him out as being a criminal or as having a reprehensible way of living in order to cause exposure to the disrespect of others. Our client may suffer serious harm and damage to his character, personal reputation, career and profession as well as financial harm as a result of the defamatory statements that are being disseminated about him. We are currently evaluating the impact of these statements.

We would like to bring to your attention that defamation is a criminal offense under the Swedish Penal Code. It can also be grounds for a civil claim for compensation for damages in accordance with the Swedish Tort Liability Act.

We are monitoring the situation and will consider taking legal action against any person found to be making such statements about our client, including but not limited to seeking damages. We hereby ask you to refrain from making any such defamatory statements about our client.

CEASE AND DESIST - DEFAMATION

Dear Ms. Dinc,

As previously stated to you in a letter sent to you in January 2019, we represent prof. Umut Ozkirimli. We then contacted you with regard to certain defamatory statements that you had made with the obvious aim of pointing out prof. Umut Ozkirimli as a person of low morality who had committed crimes.

It has come to our attention that you have not ceased with your attempts to point out prof. Ozkirimli as having a reprehensible way of living etc. It is obvious that you still seek to expose him to the disrespect of others.

We understand that you feel empowered by #MeToo and feel strongly about making a change regarding patriarchal structures, discrimination and women's rights. We do not wish to limit your right of free speech but inform you that free speech has its limits also in Sweden.

Our client may, as you are aware of, suffer serious harm and damage to his character, personal reputation, career and profession as well as financial harm as a result of the defamatory statements that are being disseminated about him.

We feel impelled to once again bring to your attention that defamation is a criminal offense under the Swedish Penal Code. It can also be grounds for a civil claim for compensation for damages in accordance with the Swedish Tort Liability Act.

With regard to what is stated above, prof. Ozkirimli has filed a report to the police. As his legal representatives we consider taking legal action, including, but not limited to, seeking damages.

We hereby ask you to refrain from making any such defamatory statements that could harm our client.
